RE: CHILD SAFETY AT ROBLOX CORPORATION

Dear Members of the Board:

We write this open letter as parents of children who were sexually abused and exploited after being targeted and groomed by predators using Roblox. We speak both for our own children and for the hundreds of families whose names appear in the attached Appendix, and we demand that Roblox Corporation stop its improper and shameful attempts to force these vulnerable, sexually abused and exploited children into secret arbitration proceedings. These children deserve their day in court.

Roblox's executives never miss an opportunity to proclaim that child safety is the company's highest priority. The company's Chief Safety Officer, Matt Kaufman, has boasted that Roblox is "one of the safest online environments for our users, particularly the youngest users." He also has assured NPR that "any time anything happens to a child that puts them at risk is one too many." Chief Executive Officer David Baszucki has similarly insisted that "even one bad incident is one too many." Roblox also declares that "our values and principles are what guide everything we do at Roblox," that "our values are at the core of everything we do," and that "[we] strive to make decisions with everyone's best interests in mind," while prioritizing "community before company." The company further claims that it is "responsible for both the intended and unintended consequences" of its actions. These "values and principles" are published prominently on Roblox's [own website](#). While repeating these promises and values in public, Roblox is at the same time attempting to silence abused and exploited children in secret arbitration, seeking to hide the very failures those words are meant to deny.

Secret arbitration is not protection; it is concealment. By trying to force sexually abused and exploited children to tell their stories only in private, confidential proceedings, Roblox seeks to protect predators and itself, not its users. This secrecy denies parents the knowledge they need to keep children safe, strips survivors of agency, reinforces their exploitation, shields systemic failures from scrutiny, and blocks the public accountability that could prevent future harm. It is also flatly inconsistent with Roblox's stated values. No company that claims to put "community before company" can in good conscience attempt to silence child victims to protect itself. No company that claims to be "responsible for the unintended consequences of its actions" can attempt to bury those consequences in secret proceedings. And no company that says its values "guide everything we do" can resort to forced arbitration without exposing those values as nothing more than marketing that misleads parents into believing that Roblox actually prioritizes the safety and wellbeing of its child users.

Congress has already sent an undeniable message: forced arbitration in cases of sexual assault is morally reprehensible and will not be permitted. The Ending Forced Arbitration of Sexual Assault and Sexual Harassment Act passed because our society recognized that silencing survivors serves only those who cause harm. Roblox has fought this federal law at every turn, wrongly claiming that the EFAA does not apply to cases involving children who were targeted, groomed, and sexually assaulted or exploited by predators using Roblox. If good conscience were not enough, the EFAA stands as a clear and public condemnation of the very tactic that Roblox is now shamefully attempting to use against the most vulnerable of all survivors—sexually abused and exploited children.

When we allowed our children to use Roblox, we relied on the company's promises of safety. We believed Roblox when it said that this was a safe and civil community for the youngest users. We never imagined that predators would be able to use Roblox to reach our children, groom them, and ultimately sexually exploit and assault them. And we never imagined that after failing to protect them, Roblox would resort to improper and shameful tactics to compound these tragedies and try to ensure that the truth can never be told in open court.

Our children's experiences are not rare accidents. They are the result of systemic safety failures that will continue if they are hidden from public view:

- We are the parents of a young teenage boy who was targeted by a known predator in a Roblox game and then coerced with Robux into sending graphic, sexually explicit images and videos of himself on another platform. We are not exaggerating when we say that our son's life will never be the same. He is haunted by the online abuse he suffered. That will never go away. And we are haunted by the trust we placed in Roblox to provide a safe place for our son. Not a day goes by that we don't wish that we had never let him use Roblox. Our son has sued Roblox to hold it accountable for its role in the exploitation he suffered and to bring awareness to other families of the dangers of the platform. In response, Roblox has relentlessly sought to force our son into confidential arbitration. Roblox seeks to silence our son. But he will not be silenced. Nor will we. – S.K. & E.K. (Washington).
- My son—an autistic child who found joy and connection on Roblox—was targeted and groomed by an adult predator who operated freely on Roblox. The pain and confusion this caused were more than he could navigate at his young age, and I ultimately lost him to suicide when he was just 15. No parent should have to endure what my family has. By trying to force his case into arbitration rather than allowing it to be heard in open court, Roblox is choosing secrecy over accountability and attempting to silence the pain of families like mine. Roblox should be ashamed of choosing legal maneuvering over accountability, transparency, and basic human decency. – Rebecca Dallas (California).
- We are the parents of an amazing, talented, and brave teenage girl. She means the world to us. Her life was devastated by a predator who targeted and groomed her on Roblox and then

extorted her into sending sexually explicit images and videos of herself on another platform. We cannot even begin to describe how this experience has impacted her—not just mentally but physically through self-harm and an attempted suicide. After she sued Roblox, we were shocked and appalled to learn that the company is trying to force her into confidential arbitration. She deserves her day in court. All these children do. – A.J. & S.J. (Florida).

- When my daughter was 15 years old, she was sexually exploited and assaulted by a man who found and groomed her on Roblox. He used Roblox to target her and then manipulated her into sending sexually explicit images of herself on another platform. Ultimately, he sexually assaulted her in our own home. This predator should never have had access to my daughter, but he did because of Roblox. I want justice for my daughter. Justice cannot be sought in the confidential arbitration proceedings that Roblox is trying to force her into. If you want to be complicit in this company's abusive tactics targeted at traumatized children, then shame on you. But I urge you to do the right and moral thing. – S.C. (Texas).

These are not stories that should be buried. They are warnings every parent deserves to hear.

We demand that Roblox immediately cease all attempts to compel any child sexual abuse survivor into arbitration and publicly commit to never again using this shameful tactic in such cases. You have already failed to protect our children from sexual predation. Do the right thing now.
